2. As per Benami Transaction Act, owner has to specify the house where he would live and where tax on rental income has to be paid. Members are therefore requested to submit details of plot/house they are holding.
3. It may be seen from the statement that occupancy of society plots is very poor. Members have also not furnished an affidavit required by Notice No. 73 that they have not sold their plots and the vacant plots are still in occupation of the members.
4. Attention of the members is also invited to Notice No. 54 wherein it has been intimated that members are required to visit their plot at least once in a month so that they are properly maintained.
